What information do we collect and why?

How long do we keep personal information?

Sharing your information

We will never sell your information to other organizations for use for their own purposes. However,

we do share your information with national, county and local associations where required for league

registration and competition entry purposes.

Storing your information

Your information is only stored by the Hon. Secretary and the Hon. Treasurer at their homes on

password protected computers and devices. A list of members' names and addresses will be kept in

the steward's office.

Your rights

GDPR/Data Protection Act 2018 gives you certain rights over your data and how we use it. These

The right of access to personal data that RPBC holds about you

The right to have inaccurate data corrected

The right to have data deleted subject to certain conditions

The right to object to processing
